Subject: Changes to the Combined Demurrage and Detention Tariffs in China – Export Effective 15th May 2025

Upcoming change to the quantum of the Combined Demurrage and Detention tariff for shipments from China. The revised tariff will take effect on May 15th, 2025, based on the actual departure date of the cargo.
