**Subject: Changes to the Combined Detention and Demurrage Tariffs in China – Import Effective 15<sup>th</sup> May 2025**

Please be informed of the upcoming change to the quantum of the Combined Detention and Demurrage tariff for shipments to China. The revised tariff will take effect on May 15<sup>th</sup>, 2025, based on the actual arrival date of the cargo.
