### **Subject: Changes to Combined Detention and Demurrage Tariff in Qatar – Effective 1<sup>st</sup> July 2025**

Please be informed of the upcoming change to the quantum of the Combined Detention and Demurrage tariff for shipments to and from Qatar. The revised tariff will take effect on July 1st, 2025, based on the actual arrival or departure date of the cargo.
