## Subject: Changes to Demurrage and Detention Tariff in Japan – Export Effective Date: 11<sup>th</sup> August 2025

Please be informed of the upcoming change to the quantum of the Demurrage and Detention tariff for shipments from Japan. The revised tariff will take effect on August 11<sup>th</sup>, 2025, based on the actual departure date of the cargo.

In addition, split method will continue to be used to calculate the applicable Demurrage or Detention charges upon expiry of the free time offered.

Detention charges for exports are calculated from the time of 'actual' pull out of the empty container from our appointed empty container depot to the delivery of the laden container at the terminal or ICD.
